CAW's mission is to improve the life of New York City youth through the visual and multimedia arts. CAW serves thousands of young people each year, primarily in Upper Manhattan, through in-school and out-of-school-time classes,(continued on Schedule O)

Creative Art Works (CAW) had its most extensive Public Art Youth Employment year to date, offering 196 apprenticeships (a 22% increase over the prior year) and the completion of 8 works of large-scale public art and seven multimedia projects (imparting skills in videography, graphic design, digital photography and creative writing) in FY 2017. Youth Apprentices aged 14-24 were given full-time summer jobs and part-time after-school jobs; they created murals in Manhattan, the Bronx and Brooklyn, five of which were also the subject of youth-created mini-documentaries created by our summer multimedia apprentice team. Starting with concept development through to public unveiling, all CAW apprentices developed tangible employment skills as well as life skills such as leadership, teamwork, the power of taking initiative and responsibility. CAW's Out-of-School-Time (OST) arts programs provide K-12 students with enriching, educational activities outside of the regular school day. CAW provided 42 extended OST arts programs in FY17, a 40% increase over the prior year, serving over 800 participants. Conducted in after-school settings and on Saturdays, in NYC public schools, community and cultural centers, foster-care placement and juvenile detention facilities, CAW's OST programs, which each ran for an average of 8-14 weeks and often in consecutive semesters, provided safe and engaging educational environments for creative self-expression. All provided professional teaching artists imparting artistic and developmental skills through a wide variety of art and digital media, including but not limited to figure drawing, printmaking, graphic novels, mixed media, urban design, sneaker branding, and sculpture with found materials. Creative Art Works' In-School arts programs served 350 students in FY2017, a 70% increase of the prior year. Programs included arts integration programs in anatomy and physiology, forensic science, and literature in both English and Spanish. Specialized curricula included lessons tailored for Students with Disabilities, Emerging Bilingual Students, and English Language Learners. In each case, CAW's professional teaching artists collaborated with school teaching staff and administrators to align lesson plans with the core curriculum, showing demonstrable impacts on academic behaviors and performance. Curricula were designed in keeping with the National Core Arts Standards, New York State Learning Standards for the Arts, and the New York City Blueprint for Teaching and Learning in the Arts.
