CAW serves thousands of young people each year, primarily in Upper Manhattan, through in-school and out-of-school-time classes, community art making events (continued on Schedule O)

4a (Code:) (Expenses \$ 411,625 including grants of \$) (Revenue \$ 266,435) Creative Art Works continued to run its Public Art Youth Employment programs remotely in fall of 2020 and spring of 2021 in order to sustain opportunities for NYC youth through the pandemic, and returned to serving youth in person in the summer. CAW successfully offered more than 267 Youth Apprenticeships through the digital arts with a social justice focus and the in-person creation of four works of large-scale public art, making FY21 our biggest creative workforce development year to date. Youth Apprentices (YAs) from the five boroughs of NYC, aged 14-24, were given part-time jobs after-school and/or during the summer. Digital Arts Youth Apprentices (YAs) worked and learned remotely, and mural YAs worked in person in either case under the guidance of CAW Teaching Artists and program management staff. Youth were engaged in collaboration with two NYC public high schools and community-based organizations. (Cont on Sched O)

4b (Code:) (Expenses \$ 268,456 including grants of \$) (Revenue \$ 221,394) CAW's Out-of-School-Time (OST) arts programs provide K-12 students with enriching, educational activities outside of the regular school day. CAW served more than 550 participants with 14 OST programs in collaboration with 10 partners in FY21. Programs were conducted remotely during the 2020-2021 academic year and in person during summer vacation, in partnership with NYC public schools, community-based organizations, supportive low-income housing, and the NYC Summer Rising program. Programs ran for a range of 6-14 weeks and often in consecutive semesters, providing safe and engaging educational opportunities for creative self-expression and connection with peers. 4c (Code:) (Expenses \$ 216,017 including grants of \$) (Revenue \$ 111,208) Creative Art Works' In-School (school day) arts programs served 1,085 students through 14 different remote programs with 11 partners during the 2020-2021 academic year. Arts integration programs included anatomy and physiology, English Language Arts and "Foundations" for high school freshmen, and digital arts with a social justice focus. Arts-in-education programs included filmmaking, portraiture and identity, and mural design. Two Active Design murals were also created and installed in schools in partnership with the NYC Department of Health. CAW's professional teaching artists and management collaborated with school teaching staff and administrators to align lesson plans with the core curriculum, and also to infuse a trauma-informed approach to mitigate the challenges of the ongoing pandemic, showing demonstrable impacts on student engagement and well-being in the remote environment.
