4a (Code: ) (Expenses \$ 464,292 including grants of \$ ) (Revenue \$ 11,120 ) Creative Art Works (CAW) expanded its iconic Public Art Youth Employment programs into the academic year with three after-school employment programs, engaging a total of 67% more participants in 2014 over 2013. The growth of this Youth Employment program grew out of its long-term successful summer programming. In CAW's most robust year ever, young adults 14-24 old were given full-time summer jobs and part-time after-school jobs; they created large-scale public art and multimedia projects around Manhattan. Starting with concept development through to public unveiling, they gained tangible employment skills as well as general life skills such as leadership, teamwork, responsibility, and the power of taking initiative creating five murals and a related documentary video published a weblog and envisioned and completed dynamic culminating event brochures. After meaningful interactions with clients and stakeholders, our young artists by the end of the program were

4b (Code: ) (Expenses \$ 283,189 including grants of \$ ) (Revenue \$ 34,025 ) Out-of-School-Time (OST) arts programs provide K-12 students throughout Upper Manhattan with enriching, educational activities outside of the regular school day. CAW provided 70% more OST classes in 2014 over 2013, including adding five new venues. Conducted in after-school settings and on Saturdays in NYC public schools, libraries, and community and cultural centers, CAW's OST programs provided safe, engaging and fun environments for creative self-expression. Each program ran for a semester and provided meaningful opportunities in which students worked with professional teaching artists learning artistic and developmental skills through mixed media, digital photography, videography, animation, installation art, mural painting, graphic novels, and three-dimensional sculpture. Structured as apprenticeships for middle schoolers and as interdisciplinary, literacy-based programs for the elementary age, participating students demonstrated enhanced artistic, social and

4c (Code: ) (Expenses \$ 74,092 including grants of \$ ) (Revenue \$ 10,000 ) Creative Art Works' In-School arts programs added an additional middle school in 2014, mitigating a lack of arts education by providing art-based and/or integrated curricula during the school day; CAW classes increased by 174%, including a new bilingual program for an entire Spanish-speaking population. CAW's professional teaching artists collaborated with school teaching staff and administrators helping them meet mandated arts education requirements and aligning lesson plans with core curriculum, showing demonstrable impacts on school attendance and performance. Curricula were designed in keeping with the National Core Arts Standards, New York State Learning Standards for the Arts, and the New York City Blueprint for Teaching and Learning in the Arts.
