CAW's mission is to improve the life of New York City youth through the visual and multimedia arts. CAW serves thousands of young people each year, primarily in Upper Manhattan, through in-school and out-of-school-time classes,(continued on Schedule O - 06a.)

Creative Art Works' Public Art Youth Employment program offered 196 apprenticeships in FY 2018 (in line with FY2017 and a 22% increase over FY2016), creating seven works of large-scale public art and seven multimedia projects while imparting skills in videography, graphic design, and digital photography. Youth Apprentices, aged 14-24, were given full-time summer jobs and part-time after-school jobs. They created murals in Manhattan, the Bronx and Brooklyn, five mini-documentaries (by our summer multimedia apprentice team), an oral histories project at West Harlem Group Assistance's Randolph Houses, and a public health PSA project in collaboration with NYC DOH East Harlem Neighborhood Health Action Center. CAW's Out-of-School-Time (OST) arts programs provide K-12 students with enriching, educational activities outside of the regular school day. CAW served over 1,000 participants with more than 30 OST programs during the 2017-2018 academic year, a 19% increase in participants over the prior year. Programs were conducted in after-school settings and on Saturdays, in NYC public schools, community and cultural centers, and ACS's foster care facility. Each program ran for a range of 8-14 weeks and often in consecutive semesters, providing safe and engaging educational environments for creative self-expression. All programs provided professional teaching artists imparting artistic and developmental skills through a wide variety of art and digital media, including but not limited to figure drawing, printmaking, graphic novels, mixed media, urban design, stop-motion animation, and sculpture. Creative Art Works' In-School arts programs served nearly 500 students during the 2017-2018 academic year, a 43% increase over the prior year. Programs included arts integration programs in anatomy and physiology and the humanities. Specialized curricula included lessons tailored for Emerging Bilingual Students, English Language Learners, and honors students on a HS medical track. In each case, CAW's professional teaching artists collaborated with school teaching staff and administrators to align lesson plans with the core curriculum, showing demonstrable impacts on academic behaviors and performance. Curricula were designed in keeping with the New York State Learning Standards for the Arts and the New York City Blueprint for Teaching and Learning in the Arts as well as the emerging defined guidelines of Creative Youth Development.

Participating students demonstrated enhanced artistic, social/emotional and problem-solving skills; programs were further tailored to enhance school engagement and attendance as well as outcomes for English Language Learners.
